- B. An application for a permit for any proposed work shall be deemed to have been abandoned 180 days after the date of filing (12/28/2010) per CBC Section 105.3.2. The abandoned permit will be expired and new fees must be paid. The applicant may request a 90-day extension by submitting a letter to the Chief Building Official, demonstrating justifiable cause, prior to the expiration date.

1	<ul> <li>a) Any work that is proposed in, or that projects into, the public right of way requires an encroachment permit. Encroachment permits may be obtained at 300 Richards Blvd (3<sup>rd</sup> floor public counter) from the Department of Transportation, Development Engineering Division.</li> <li>b) As per the Business and Professions Code, due to the occupancy / type of work proposed, these plans will require the stamp and signature from a registered engineer or a licensed architect. See the attached CDD form #0236 titled "Who May Prepare Plans." <i>The first cycle plans were stamped and signed by a registered design professional, however the second cycle plans were not. Per the Business and Professions Code, due to the use, the stamp and signature of a registered design professional is required.</i></li> </ul>

4	<ul> <li>a) Please provide details to verify compliance with CBC Section 1011 for exit signage. <i>Provide details for illumination of the egress path at the second exit – all the way to the public way.</i></li> <li>b) Please provide details to verify compliance with CBC 1011.3 for tactile exit signage. <i>Details for tactile exit signage were not provided at second cycle submittal. See CBC 1011.3.</i></li> <li>c) Please provide details for handrails at the ramp to verify compliance with CBC 1133B.5.5. <i>Please provide details to verify compliance for handrail extensions as stated in 1133B.5.5, show on the plans where the extensions will be, there dimensions etc. Note: see CBC 1133B.8.6; projections with a leading edge between 27 and 80 inches from the walking surface shall project no more 4". (The lower / return rail for the handrail extension is not a hazard for the visually impaired).</i></li> </ul>	AO.1
